1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

St. Xavier's College, Burdwan was established in the year 2014 as a part of the golden jubilee project of St. Xavier's School, Burdwan. It is the second college launched by the Jesuits of Calcutta Province, making it the 50th Jesuit Institution of Higher Education in India and the fourth in Bengal. Having successfully stepped into its tenth year of academic excellence, the college espouses the principle objective of Jesuit Education which is to form "men and women for others". The institution was inaugurated on 11th July, 2014 by Bishop Cyprian Monis of Asansol and has since then been steered by the leadership of the Principal, Rev Dr. G. Paul Arockiam, S.J.

Sprawled across 5.319 acres of environmentally sustainable and botanically enriched campus area, the college strives to meet the long-standing need and demand in the region for good quality higher education in English Medium. It is affiliated to The University of Burdwan while also being AICTE approved and ISO 9001:2015 Certified. The institution began its journey by offering Honours Degree Courses in various disciplines of Arts, Science and Commerce like English, Accountancy (Commerce), Biotechnology, Computer Science, Sociology and Geography. Within three years of its inception, that is, by 2017 the institution expanded its academic base to include Masters' Degree Program in English. Exhibiting sincere consistency in academic growth, the institution added two new Degree Programs, BCA and BBA, in 2018 and 2019 respectively.

The college boasts of a decade of academic eminence and discipline, and has established itself firmly as a front-runner in quality education. The modern state-of-the-art infrastructure creates an ambience of reflection and harmony for young minds to thrive. The college attracts students from neighbouring districts, states and Bangladesh, making for a rich cultural experience on campus. Interdisciplinary academic approach, Collaborative learning and Innovative teaching are some of the hallmarks of the institution. The institution facilitates creative capabilities and sense of social awareness of students by engaging them in co-curricular activities and programs like NSS, AICUF and Social Outreach. The college also has an active Alumni Association XCAAB which is the bearer of the institution's values and legacies.

- Students receive academic, psychological and professional guidance, and benefit from seminars, workshops, skill enhancement programs, and entrepreneurship initiatives.
- Additional courses beyond the curriculum broaden skill sets and career prospects.
- MoUs and collaborations with expert institutions promote interdisciplinary learning and professional expertise.
- Inclusive education, low dropout rates, high academic performance, and successful placements characterize the institution.
- Ethnic, linguistic, religious and socio-economic diversity among students fosters an inclusive environment.
- Environmental sustainability initiatives, community welfare programs, and a strong alumni network drive continuous improvement and institutional development.

Institutional Weakness

- The institution's lack of postgraduate departments limits advanced academic opportunities for students and faculty members and restricts the growth of specialized research and higher education.
- As a self-financed and affiliated college, St. Xavier's College, Burdwan has limited administrative autonomy, hindering opportunities of quality enhancements and implementation of new initiatives in academic and research activities.
- Despite installing solar power plants and promoting energy efficiency, more comprehensive projects and enhanced waste management are needed, as indicated by a thorough Green Audit.
- There is a lack of practical, industry-oriented learning opportunities, restricting real-world exposure.

Institutional Opportunity

- The institution can enhance student skills and employability by introducing more skill-oriented programmes.
- Increasing solar energy generation on campus can promote sustainability and reduce costs.
- Faculty can secure more research projects, fostering interdisciplinary research and enhancing academic advancement and institutional reputation.
- Upgrading e-learning tools can empower teachers to create innovative e-content.

Institutional Challenge

- Regular recruitment programs are essential for increasing placement opportunities, requiring systematic planning and industry connections.
- Conducting adequate national/international seminars, conferences and research endeavors is difficult due to financial constraints.
- Keeping pace with rapid technological advancements requires ongoing investment in infrastructure and training.
- Declining enrollment due to changing educational trends necessitates strategic adjustments.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

St. Xavier's College, Burdwan is affiliated to the University of Burdwan and follows the curriculum as designed by the aforementioned university. At present the college executes the CBCS (Choice Based Credit System) for the Second and the Third Years, adopted in the academic session 2017-18, as well as the NEP (National Education Policy) 2020 for the First Year, adopted in the academic session 2023-24.

Based on the curriculum and syllabus structured by the University, the college plans and executes the same based on the academic requirements of the students. The syllabus is allocated among the different faculty members of the various Departments based on their specialization and areas of interest, following which lesson plans are designed by the respective faculty members. The college also follows a system of CIA (Continuous Internal Assessment) to ensure quality dissemination of knowledge and evaluation of the same. The CIA components include two class tests, one mid semester examination, assignments with power-point presentations and end semester examination. The college takes an active interest in the academic enhancement of the learners which is undertaken through various programmes such as Add-On and Certification Courses offered by the various Departments. The institution is modelled on the Jesuit values of holistic individual development, and therefore initiates programmes integrating values such as professional ethics, gender parity, human morals and environmental sustainability. Workshops, Seminars, Invited Lectures and other inter-disciplinary events facilitate the growth and development of learners following the above merits. Based on the requirements of the curriculum, the institution encourages students to take up project works, field works and internships. The college provides adequate training for the above programmes and keeps a meticulous record of participating students in the same.

The college maintains a robust feedback system from all its stakeholders including students, employees, employers and the alumni. The feedback generated is evaluated and discussed at the administrative and departmental levels, and active redressal methods are initiated based on the outcomes. This approach supports the amalgamation of the interests of the stakeholders as well as the Institution.

Teaching-learning and Evaluation

St. Xavier's College, Burdwan, has consistently demonstrated excellence in teaching, learning, and evaluation. The enrolment percentage (64.33%) over the years has been satisfactory, reflecting the institution's popularity and the trust it garners among prospective students and their guardians. As a minority institution, it does not follow the reservation policies set by the Government of India and the State Government. However, the percentage of seats filled for reserved categories such as SC, ST, and OBC reflects its inclusive admission policies promoting diversity and equal opportunity.

The college maintains a moderate student-teacher ratio of 27.5:1, ensuring personalized attention and quality education. The percentage of full-time teachers against posts sanctioned by the governing body aligns with departmental requirements, with more than 70% of the full-time teachers holding advanced qualifications such as NET, SET, M.Phil., and Ph.D. These qualified faculty members employ advanced pedagogical methods, contributing to a congenial academic environment.

The institution uses student-centric methods, including experiential learning, participative learning, peer learning, and problem-solving methodologies. It also administers mentoring sessions and special programmes for advanced and slow learners. Students are encouraged to engage in activity-based learning, cocurricular activities, workshops, seminars, field visits, and internship programmes to apply their curricular knowledge in real-world scenarios. Additionally, teachers go beyond traditional pedagogical methods and embrace ICT-enabled tools, including e-resources, to facilitate effective teaching and learning processes.

The college employs a transparent examination policy to conduct continuous internal assessments, contributing towards students' preparedness for the final university examination. Students' concerns regarding examinations and evaluations are addressed promptly and forwarded to the competent authority in a time-bound manner.

The institution clearly states and displays the Programme Outcomes and Course Outcomes for all programmes on its website. The attainment of these outcomes is regularly evaluated to ensure that educational objectives are met. Over the past five academic years, the pass percentage of students has been 92.62%. The number of final-year students who passed the university examinations, along with those who progressed to higher education and were placed in various sectors, consistently reflects the institution's effective teaching methodologies.

Research, Innovations and Extension

The facilities provided and efforts made by the institution to promote a "research culture" are commendable. Serving the community through extension, which is a social responsibility and a core value to be demonstrated by institutions, is also a major part of this criterion.

The institution has received a governmental grant under the project name "A Study of Abiotic Stress on Callus Culture of Some Cruciferous Vegetables for assessment of Indole-3-Carbinol Content" from "DST-SERB".

An innovative eco-system has been created in the institution to promote innovation, transfer of knowledge and entrepreneurship. As a part of Incubation Centre Facility, an "ED cell" has been set up for nurturing innovative entrepreneurial ideas among the students. In the creation of a research conducive ecosystem, the institution has automated the library using 'KOHA' integrated library Management System (ILMS). The library currently has 2870 no. of titles with 4538 copies of books available for students and faculties with access to INFLIBNET and N-List.

The faculties of the institution are active in publishing in UGC care listed journals, national/international conferences, books and chapters in edited volumes. There are 16 UGC care-listed publications. There are 24 publications/chapters/papers in edited volumes/books/journals published in the last five academic sessions. The college has organized a total of 94 seminars/workshops in the last five academic sessions.

31 extension activities were carried out in the neighborhood community, sensitizing students to social issues, for their holistic development by Extension Programme/ Social Outreach Committee. For serving the community through extension activities, this institution has received awards and recognitions from government/

government recognized bodies. The Institution has also received an award for maintaining “Best Green and Environment Friendly Campus” from Altruist Yuva Welfare Society.

There is total 26 functional MoUs with various institutions, industry/ corporate houses. Both the parties noted the importance the value of cooperation and have agreed to enter into Memorandum of Understanding (MoU) regarding academic collaboration, industrial collaboration and other mutual benefits. MoU is to make possible academic and cultural exchange between both the parties based on the principles of mutual equality and the reciprocity of benefits.

Infrastructure and Learning Resources

The college encompasses a range of 5.319 acres of land. It has three building blocks, Administrative, Academic and Canteen block. The total built up area of the college are 8010.13 square meters, Consisting of eight departments with total 43 Class rooms including 4 Smart class rooms equipped with ICT facilities. It has seven laboratories in various departments. The College also has 3 audio visual room for video lecture and conferencing. For cultural purposes the college has three ICT enabled seminar halls and two air conditioned parlor. The college has six set of Washrooms in each floor separately for male and female faculty, staff, students and separate arrangement for ‘Divyang’ students as well. The college provides drinking water by 10 water purifiers and two water cooler. There is a student support cell where reprographic services are provided. There are two reception desk, a inter faith prayer hall, a ‘XCAAB’ room for alumni association, pantry, maintenance room, girls common room, students common room, ICC room, college & E-resource Library, counselling room, documentation room, store room, staff common room, IQAC room, college office, exam section, Accounts section, principal’s office, conference room, an exam hall with 130 seating capacity & two separate modern elevators.

The college has three ICT enabled air-conditioned seminar halls & a spacious open stage in its ground.

This institution has an indoor games room where games like table tennis, carom, and chess are played. Basketball, badminton and other games are also played in campus.

The library of the college is automated, using ‘KOHA’ integrated library Management System (ILMS). The library has 2870 no. of titles with 4538 copies of books available for students and faculties. It has an E-Resource section with 5 computers along with LAN connections for accessing various e-journals & e-books.

The college has sufficient IT infrastructure containing Wi-Fi enabled campus. There are four Ethernet connections with a range of 70 - 150 MBPS bandwidth speed. The College has 111 computers, out of these 58 computers are solely available for the students use. The student computer ratio for the latest academic year is **11.86 : 1**.

Student Support and Progression

St. Xavier’s College, Burdwan facilitates student access to scholarships and freeships via prompt notifications, communications, and verification protocols. Over the past five years, numerous students have availed themselves of merit cum means scholarships, minority scholarships, and fee concessions.

In the last five years, the college has meticulously orchestrated 106 Capacity Building and Skill Enhancement

Programmes. These initiatives focus on enhancing students' capabilities, knowledge, and competencies through workshops, seminars, and training sessions. Faculty members are instrumental in motivating and guiding students towards academic and professional excellence.

Our College prioritizes mentoring students for competitive exams and career planning through proper guidance. MoUs with academic institutions and industries enhance career opportunities, supported by career counselling and a Placement Cell.

The Grievance Redressal Cell at our college acts promptly to address grievances, respecting stakeholder dignity and fostering a secure, inclusive environment for all. The Internal Complaints Committee (ICC) handles sexual harassment issues swiftly. Campaigns against ragging, led by the Anti-Ragging Committee, and ICC's awareness initiatives are integral. Our college has upheld a commendable record with no incidents in the past five years.

A substantial number of students pursue higher education at esteemed institutions and secure employment. Our students consistently achieve academic distinctions and gain admission to premier institutes. Many excel in competitive exams like NET, GATE, CAT, MAT, WB JECA, and secure placements in various Government and non-Government organizations upon graduation.

Our College actively promotes student engagement in diverse co-curricular and extra-curricular activities, facilitating with necessary resources. Our students have earned numerous gold medals and accolades. Our College has excelled in sports and cultural pursuits, fostering a dynamic campus culture that enhances student development and promotes their talents.

The College benefits from an engaged alumni network that actively contributes to various institutional endeavours throughout the academic year. With a registered and active Alumni Association, these former students play a pivotal role in participating enthusiastically in diverse activities of the institution.

Governance, Leadership and Management

St. Xavier's College, Burdwan, exemplifies a robust governance framework deeply rooted in its Vision and Mission, guided by the principles of the Jesuit Order and overseen by the St. Xavier's Burdwan Educational Trust and Catholic Mission of Western Bengal. Embracing the NEP 2020, the institution integrates decentralized decision-making to empower departments, fostering responsiveness and innovation. Strategic initiatives prioritize academic excellence, infrastructure development, student support, and industry collaborations. Underpinning these efforts is a robust governance structure led by the St. Xavier's Burdwan Educational Trust and adhering to Jesuit principles, ensuring ethical governance and educational excellence. The Governing Body, headed by the President, formulates policies and oversees operations to align with mission objectives. The institution's adoption of e-governance enhances administrative efficiency across all functions. Comprehensive staff welfare policies provide financial support for faculty development, medical benefits, educational sabbaticals, loans, and internet access, cultivating a supportive work environment. Academic resources are enriched through e-libraries, seminars, and career development opportunities, bolstering research and growth. Indoor sports facilities contribute to staff well-being and community cohesion. Regular audits, both internal and external, ensure compliance and operational

transparency, facilitating strategic resource allocation for academic initiatives and infrastructure development aligned with institutional goals. Internal Quality Assurance Cell (IQAC) plays a pivotal role in monitoring academic standards, implementing assessment systems, and promoting holistic student development through co-curricular activities and feedback mechanisms. Its activities, including audits focused on gender equality, green initiatives, and energy efficiency, underscore the college's commitment to academic rigor, infrastructure enhancement, inclusive education, ethical governance, and community service. Participation in NIRF and ISO 9001:2015 certification further solidify its dedication to excellence in higher education. St. Xavier's College, Burdwan, thus stands as a beacon of educational leadership and community impact, driven by its enduring commitment to excellence and service.

Institutional Values and Best Practices

Gender sensitization is fostered with annual audits, facilities like sanitary napkin vending machines and educational programs on equity and rights, along with integrating gender topics in the curriculum and encouraging participation in sports and cultural activities. Solar energy plant is implemented and used in the canteen, staff quarters and indoor games area. Other energy conservation measures like rapid uses of LED, policies related monitoring energy usage are followed. The institute manages degradable and non-degradable wastes, segregates solid waste for municipality collection, maintains a plastic-free campus, and implements recycling initiatives as part of green practices. Water conservation is also practiced in our college through rain water harvesting system. Green campus initiative is taken in different ways - like tree plantation drive and spreading the awareness to keep the premise green. Elevators, ramps, disabled friendly washroom are also available in both buildings. Apart from the parking area the entire zone is free from vehicles. Students and staff members follow certain measures to maintain the cleanliness of the campus. College promotes diversity and social responsibility through inclusive admissions, cultural events, multiple seminars, social awareness programmes and social out-reach programmes and health initiatives, fostering a harmonious educational environment.

The objective of Best Practice: 1 –“**Preparatory Pathway**” is to bridge the gap between school and collegiate education. It is to meet the student's communicative requirements and to induct institutional values. "**X-Caritas: Be the reason for their Smile**" and other Ongoing Services for the Under-Privileged Children is the second Best Practice of the college. This event is voluntarily organized by the AICUF, NSS, X-EVE and the Social Outreach Committee for extending a helping hand to the underprivileged children, and secondly to include a moral sense in the present student who once out of the institution innately commit themselves to social work.

Institutional distinctiveness “**Fostering Holistic Development with Jesuit Emphasis on Punctuality and Regularity**” form self-confidence to better preparedness on the academic front. They must be prompt and consistent by maintaining different parameters like following strict college timing along with the protocols of keeping late slips and admit slips, and others.

St. Xavier's College, Burdwan is affiliated to The University of Burdwan and follows the Choice Based Credit System since 2017-2018. The curricula for the eight Undergraduate Programs in Arts, Science and Commerce (B.A. in English, B.A./B.Sc. Geography, B.A. in Sociology, B.Com. in Accountancy, B.Sc. in Biotechnology, B.Sc. in Computer Science, Bachelor of Business Administration and Bachelor in Computer Applications) have been formulated in accordance with the guidelines of UGC and the affiliating university, and is in tune with the vision and mission of the Institution. The college also has a Post Graduate Programme in English.

The emphasis of the curriculum is on overall development and knowledge acquisition. The curriculum also includes Laboratory and Project work, Workshop and Fieldwork experiences, and enhanced academic training in specific fields. The core subjects in the curriculum provide in-depth domain knowledge in the chosen program. The students are also encouraged to participate in Seminars, take up Internships and involve themselves actively in co-curricular activities.

Being an affiliated college of The University of Burdwan, St. Xavier's College Burdwan follows the Academic Calendar issued by the University at the beginning of the academic year. It clearly delineates a schedule for teaching, examination, semester break and vacations that is mostly followed by the college to ensure smooth and efficient functioning of its teaching and administrative processes. Within the same framework, the college also prepares its own calendar of events and activities before the commencement of the Academic Session and the same is communicated to all stakeholders. For transparency of functioning, the college academic calendar is placed on the college website. Departmental Faculty Meetings place emphasis on curricular planning in accordance with the specifics of the Academic Calendar.

Curricular Planning also involves allotment of syllabus to the teachers followed by preparation of Lesson Plans in accordance with the Departmental Class Routine. The Continuous Internal Assessment (CIA) process ensures regular updates on syllabus progression by faculty members and allows learners to trace their academic performance effectively. The CIA format includes two class tests, one mid-semester examination, assignments with power point presentation and end semester examination. Based on CIA performance students are also encouraged towards Remedial or Advanced Learners' programmes.

Students' Seminars, Workshops, Hands- on training, Add-on and certificate courses are conducted with the aim of expanding the academic horizon of students and gearing them towards a more inter-disciplinary learning. Various field work, project work, excursions, industrial visits, also form an integral part of the curricular framework. Such activity-oriented learning processes ensure the implementation of

innovative teaching-learning methodologies.

Response:

St. Xavier's College, Burdwan believes in comprehensive individual development of learners. Students are moulded as responsible young adults and citizens by creating awareness and addressing the socio-cultural and professional needs. Along with a standardized learning plan, the curriculum is enriched by including courses that improve an understanding of professional ethics, gender issues, human values and environmental sustainability. Such measures enhance the knowledge base of the student and gear them towards self-actualization and belongingness to the society. St. Xavier's College, Burdwan is affiliated to The University of Burdwan and adheres to the curriculum prepared and followed by the University under the Choice Based Credit System (CBCS). The syllabus ensures that the issues of gender, environment sustainability, human values, and professional ethics also get equal representation in the curriculum. Most of the programmes do have these issues addressed in their syllabi.

The B.A. programmes include courses in their syllabi that address issues relating to women empowerment, sustainable development, human values like justice, equality, liberty and rights, caste issues, rights and duties, social responsibility, child rights, sexual minority rights. For instance, The Department of English teaches courses on Indian Literature, Translation, Women's Studies, Cultural History of English, Diaspora Studies, etc. The Department of Geography teaches Environmental Geography, Disaster Management while The Department of Sociology teaches courses on Religion, Ethnicity, Crime, Deviance, Feminism and so on.

The Department of Commerce integrates courses on Human Resource Management in its syllabus which teaches coordinating, managing, and allocating human capital, or employees. It teaches modules like HR

acquisition, HR development, Performance and Compensation, Motivation and Maintenance, and Industrial Relations.

The B.Sc. programmes teach courses that include discussions on science, technology, ethical practices, professional codes of conduct and so on. Programmes like Biotechnology include courses on Human Welfare, Genetics, Forensics, Mammalian Physiology, General Microbiology, Bio Process Technology, Genomics and Proteomics and Intellectual Property Rights while Computer Science teaches courses on Internet and E-Commerce and Soft Computing.

Professional Courses like BBA include papers on Business Environment, Organisational Behaviour and Human Resource Management, Industrial Relations Laws, Wage and Compensation Laws. BCA teaches courses on Principles of Management and Advance Networking and Communication.

The Environmental Studies paper includes the study of natural resources with emphasis on renewable energy resources, the importance of conserving the present ecosystem, promoting biodiversity, perils of environmental pollution and raising awareness on environmental and social issues.

Besides, the institution has also offered Add-on/ Value added courses to facilitate better understanding of issues related to Gender, Environment, Professional ethics and Human Values.

The institution also regularly tries to integrate these cross-cutting social issues into the curriculum by periodically organizing seminars/ workshops having bearing on Professional Ethics, Gender, Human Values, Environment and Sustainability. Such practices ensure hands-on experience for the learners in cultivating an understanding of socially, culturally, environmentally and professionally relevant issues.

St. Xavier's College, Burdwan has garnered acclaim for its innovative approach to education, tailored to meet the needs of contemporary learners. Employing student-centric methodologies such as experiential learning, participative learning, and problem-solving techniques, the college enhances the overall learning experience. Faculty members utilize ICT-enabled tools extensively, including online resources and digital technology integrated into teaching practices across the campus.

The college boasts partially Wi-Fi-enabled premises with smart classrooms equipped with projectors, smart-boards, and sound systems. Additional facilities like audio-visual rooms, seminar halls, and a multipurpose hall are utilized for interactive and experiential learning sessions. Various laboratories such as Biotechnology Lab, Computer Lab, Communication Lab, Plant Tissue Culture and Phytochemistry Lab, and Geography GIS Lab are equipped with computers, projectors, and ICT facilities to support practical learning in respective disciplines.

St. Xavier's College, Burdwan swiftly shifted to digital learning environments to ensure continuity of education amidst the pandemic. Online platforms like ZOOM or Google Meet were extensively used by the faculty members for conducting classes and also for organising webinars or special lectures. Faculty members leverage platforms like Google Classroom for sharing course-related information, conducting continuous assessments, and assigning tasks. They also utilize diverse online resources such as YouTube, blogs, and digital libraries to enrich the learning experience. Moreover, faculty access scholarly databases like Google Scholar, Research Gate, and INFLIBNET to enhance their teaching materials and resources.

The college website provides seamless access to e-books, e-journals, digital theses, and international newspapers, enabling students and faculty to stay updated remotely. Software applications like Microsoft Excel, Word, Google Docs, and specialized tools like QGIS for Mapping (Geography), MATLAB, JAVA, and various programming environments (Computer Science) are extensively used to support curricular activities.

2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

At St. Xavier's College, Burdwan, the examination policy is designed to uphold transparency and address grievances in a time-bound fashion. The college strictly adheres to the instructions and guidelines of the affiliating university, i.e. The University of Burdwan, in conducting the internal assessment and preparing students for the final university examination.

Continuous Internal Assessment (CIA) plays a prevalent role in enhancing students' readiness for the final university examination by providing them with frequent feedback and opportunities for improvement. At St. Xavier's College, Burdwan, CIA encompasses the following components: Class Test 1, Mid-Semester evaluation, Class Test 2, Assignments and PPT Presentations, and End-semester/Rehearsal assessments. Each component contributes to an all-round assessment of students' knowledge and skills throughout the academic term.

Class Test 1: Assessment conducted early in the semester on select areas to evaluate understanding of topics.

Mid-Semester Examination: Evaluation conducted midway through the semester with the objective of completing half of the syllabus.

Class Test 2: Another test conducted after the mid-semester examination to measure further progress.

Assignments and PPT Presentations: Academic activities to hone research aptitude, analytical and presentation skills.

End-Semester/Rehearsal Examination: Comprehensive evaluation at the end of the semester, covering

all topics.

The CIA system encourages interactive participation in the learning process. Furthermore, St. Xavier's College, Burdwan conducts remedial classes for slow learners based on students' performance in Mid-semester examination and runs special programme (tutorials conducted by students for their fellow mates, poster-making, presentations etc.) for advanced learners.

To provide students with ample time to plan and prepare for examinations, the dates of examinations for internal assessment (Mid-Semester and End-Semester) are prominently mentioned in the academic calendar. Additionally, information regarding class tests and class re-tests is effectively disseminated through notices prominently displayed on departmental notice boards. The inclusive pattern of the examination procedure at St. Xavier's College, Burdwan allows students to appear in class re-tests if they fail to write class tests.

The examination process at St. Xavier's College, Burdwan, is characterized by its transparency. There is a separate Examination Cell that looks after the internal/external examination and coordinates with the affiliating university in examination related issues. All examination procedures, including question paper setting, evaluation, and result publication, maintain strict standards of fairness and impartiality. Students are provided with clear guidelines and information regarding examination schedules, curriculum, and evaluation parameters.

St. Xavier's College, Burdwan, has an efficient grievance redressal system to address any concerns or grievances related to examinations. In case of any grievances, students are advised to contact the Examination-Chief-Superintendent, i.e. the principal of the college through Examination Cell. Answer-scripts of examinations are shown to students after evaluation and any queries or grievances related to marks are promptly addressed. Grievances regarding marks obtained in university examination are also acknowledged with alacrity and applications are forwarded to the university for revaluation of answer-scripts.

St. Xavier's College, Burdwan, aims at ensuring that its students achieve the highest possible standards of education and skill development through precisely outlined Programme Outcomes (POs) and Course Outcomes (COs). The attainment of these outcomes is meticulously tracked and evaluated through a systematic process of result analysis.

The college uses a well-defined mechanism to analyse the final university results of both undergraduate and postgraduate courses. This analysis involves several key steps:

1. **Data Collection:** Examination results of all final-year students are collected and compiled. This includes marks obtained in individual papers and overall performance.
2. **OBE Level Calculation:** The Outcome-Based Education (OBE) level is calculated for each course on a scale of 0 to 4, where:
 - 0 to 1 = Low
 - 1 to 2 = Moderate
 - 2 to 3 = High
 - 3 to 4 = Excellent

This scale helps in quantifying the degree to which the POs and COs are attained. The calculations are based on paper wise performance of students, ensuring a comprehensive assessment of the pedagogical methodologies.

1. **Outcome Mapping:** Each course has specific outcomes linked to the overall programme outcomes. The performance of students in each course is mapped to these outcomes to evaluate Programme Specific Outcomes and how well the educational objectives are being achieved.

St. Xavier's College, Burdwan maintains a detailed record of outgoing students, tracking their progression to higher education and employment. This includes information regarding students who enrol in postgraduate programs, both within the institution and at other universities and institutes of higher education, and data about students who secure employment, including the sectors they join, respective job roles, and companies/organisations they work for.

Based on the analysis of the final university results for UG and PG courses, the college determines the overall attainment level of the programme outcomes. For instance, if the majority of courses achieve an OBE level of 3 or 4, the attainment is considered high to excellent. This consistent evaluation helps the college maintain high educational standards and continually improve its academic endeavours.

Similarly, another MOU was signed on 9th Jan' 2023 between ST. XAVIER'S COLLEGE, BURDWAN and GEO -SOLUTIONS to facilitate professional training, which can initiate the entrepreneurial ideas in the minds of the young students.

Computers and the Internet are available to students at the institute. The college is also equipped with Computer and Language Communication laboratories. Wi-Fi facilities are also available for students to access more resources. The college provides N-LIST access to both students and teachers which gives access to a wide repository of online resource materials. The library is equipped with WEB OPAC and KOHA.

IQAC regularly organizes Faculty Development Programmes for the academic growth of the faculties. IQAC has also organized awareness programmes for Intellectual Property Rights (IPR).

The college provides with No Objection Certificates (NOC) to the faculties for pursuing PhD programmes. IQAC in collaboration with the other departments organizes regular Workshops, Seminars and other extra co-curricular activities for the students and faculties.

Response:

Campus: The St. Xavier's College, Burdwan is situated at St. Xavier's Road P.O. Sripalli, Burdwan 713103, Purba Bardhaman district of West Bengal. The college is affiliated with the University of Burdwan. The College campus encompasses a range of 5.319 acres of land. The total built up area of the college is 8010.13 square meters. There are two building blocks on the Campus i.e. Administrative block and Academic block and a separate block for canteen, indoor games and parking.

Academic Facilities: The college is consisting of eight departments (8 UG & 1 PG courses) with total 43 Class rooms including 4 Smart class rooms & 3 audio visual rooms for video Lecture & conferencing equipped with ICT facilities. The college has seven laboratories i.e. Geography Lab, General Bio-Tech Lab, Biochemistry Lab, Microbiology Lab, Plant Tissue Culture and Phyto-chemistry Lab, Computer Lab and Communication Lab with ICT enabled facility. The college has 3 ICT enabled seminar halls and 2 air conditioned parlour. Also the college has an Examination hall with 130 sitting capacity. Class room 4, Class Room 5 and Class Room 6 are also used for examination purposes. Library with E-Resource section is situated at the ground floor of administrative building.

Other Facilities: The College has six set of washrooms in each floor separately for male and female faculties, staffs and students. It has separate arrangement for 'Divyang' students as well. The college provides drinking water with 10 water purifiers and 2 water coolers. There is a 'Student Support Cell' where students can take print out and photocopies. There are two reception desks at the ground floor of each building, an Inter Faith Prayer Hall, 'XCAAB' room for alumni association, pantry, maintenance room, girls common room, students common room, I.C.C room, counselling Room, documentation Room, store rooms, staff common Room, IQAC room, music room, college office, exam section, accounts section, Principal's office and conference rooms. Each building has an elevator for the staffs and 'divyang' students. For the emergency purpose, there are 13 fire extinguishers existing within the campus along with a Fire Exit facility in the Academic Building. There is an Extension and Outreach Program Cell room and an E.D. Cell room in the college as well. The seminar hall above the canteen is Loyola Multi-Purpose Hall which is also used for Yoga Centre as well. 17 CCTV camera placed within the campus. There is one dedicated transformer and one green generator for uninterrupted power supply for teaching learning purpose.

Sports & Cultural Aspect: For cultural activity, the college has three ICT enabled, air conditioned seminar halls in each block and one open stage in its campus. Every year, the Cultural Committee

organizes many cultural events. Sometimes the school Auditorium is also shared.

For indoor sports the college has one indoor sports room where carom, T-T and chess are played, for outdoor sports facility the college has basketball and badminton court. School ground is shared for other outdoor sports.

The college library spans over 2212 square feet area. It has open access with 2870 no. of titles with 4538 copies of books available for students and faculties, and 44 journal subscribed.

Highlights :

- The library is partially automated with the help of high quality, full-featured 'Integrated Library Management System (ILMS)', known as 'KOHA'.
- A stepwise automation and digitization process was initiated in June 2019 using ILMS software KOHA, version '18.11.06.000' to make the library services digital and better accessible for the members.
- Software KOHA was run on the Ubuntu platform and the server computer is connected with other client computers through LAN from June 2019 to March 2023.
- Since 1st April 2023 Cloud based Integrated Library Management Software Koha was implemented and the present version is '23.11.01.000'. This software includes modules for circulation, cataloguing, acquisitions, serials, patron management, generation of reports and more.
- Books in the Library are bar-coded for automated circulation. Using the Library Management System each barcode has been programmed to identify the title of a book, author name, item number, volume number, etc.
- The users can search, requisite and reserve their demanded books through Web OPAC the cataloguing of the Library.
- The software provides all information on the Books, References, Journals, and Periodicals. It has the complete list of categorized members – Administrators, Students, Academic Staff Members and the books they have borrowed, books which are overdue and renew.
- Email based alerts are provided to the borrowers while borrowing (Check Out), returning (Check In) and renewal of the books. Besides, the hard copy of the Accession Register is also maintained for identification, collection & development.

Subscription of E resource

- The college library is a member of National Library and Information Services Infrastructure for scholarly content (N-LIST) from 26.04.2022. It is one of the consortia under 'e-sodhsindhu', a project funded by MHRD which provide access to 6000+ e-journals & 199500+ e-books.
- The Students and the Faculties are provided separate login ID & password to access E-resources under the National Library and Information Services (N-LIST).
- The E-Resource Section is equipped with 5 desktop computers having high speed internet connectivity.

St. Xavier's College, Burdwan is dedicated in providing secure and sophisticated information technology infrastructure on campus in terms of hardware, software, and internet facilities:

- The college has 111 computers with an all-LAN enabled facility and updated configuration and is also upgraded continuously as per the requirements. 58 computers with proper internet connectivity are provided only for student usage. The College Office is also fully equipped with desktop computers, printers, scanners, Xerox machines and internet facilities.
- The library of the college is automated, using 'KOHA' integrated library Management System (ILMS) with version '22.11.03.000'. It has an E-Resource section with 5 computers along with LAN connections for accessing various e-resources through 'NLIST'. Bar code scanner is use for keeping the circulation record.

- There are four Ethernet connections with a range of 70 - 150 MBPS bandwidth speed distributed among the administrative building and the academic building with the help of 22 routers to provide easy accessibility of the internet for the students and faculties.
- Two LED TVs are fixed near the front desk of reception in both administrative and academic buildings to display the college information on a daily basis.
- The entire college is covered by 17 CCTV cameras which are monitored from the Principal's office.
- The institution has 4 ICT enabled smart classrooms and 3 ICT enabled audiovisual rooms for Teaching-Learning purposes. There are 14 projectors installed in various departments and seminar halls for audiovisual activities for various events and teaching & learning purposes.
- Biometric attendance is installed for teaching and non-teaching staff of the college.

The department support cell is equipped with one Xerox cum printing machine, one colour printer, one black and white printer and two computers for constant support for students & faculties.

The college conducts External audits annually by B. De and co., Chartered Accountant bearing Firm Reg. No. 301043E and Mem. No.304354. The Audit examines the revenues generated in terms of fees, grants, donations, from the use of space, etc. as against the expenses incurred and the assets purchased or written off. Expenses incurred on infrastructure improvement are verified and approved by the competent authority. A physical verification of the assets declared is conducted during the audit. The bank and fee reconciliation statements and the utilization of grants received are verified. We are also subject to annual scrutiny by the Income Tax Department.

Internal audits are conducted twice in a financial year by Huda & co., Chartered Accountant bearing MRN No. 306924, from 1st April to 30th September and 1st October to 31st March. The budget is prepared periodically. Financial and operational budget is approved by the manager of the society. Variances above 10% are reported to the president of the society. Minutes of the budget meeting is maintained.

Students' fees include tuition fees, admission fees, semester fees, development fees etc. is the main source of college revenue apart from charitable donations. Reliable student fee collection software is maintained and it is only used for accounting admission fees and tuition fees.

Academic expenditures, Administrative expenditure and statutory expenditure are also audited by the external auditor. Expenses include Salaries (including EPFO, ESIC), Repair and Maintenance, Gardening, Printing and Stationary, student and staff welfare, contingencies etc.

The Resource Mobilization Policy of St. Xavier's College, Burdwan emphasizes the critical role of fund management in institutional growth and development. It aims to strategically identify and utilize resources to enhance academic and non-academic activities aligned with the institution's vision. Key objectives include efficient allocation of funds across programs, transparency in financial operations, and promoting accountability.

The college primarily funds its operations through student fees in its self-financed model, supplemented by government scholarships for disadvantaged students and donations from philanthropic sources. A structured approach ensures optimal resource utilization through annual budget planning sessions between the Principal and College Accountant. Budgetary allocations are meticulously decided based on departmental requirements and project priorities, overseen by the Governing Body for final approval.

Monitoring mechanisms include regular financial reports and audits, both internal and external, ensuring compliance with financial guidelines and discouraging deficits or mismanagement. This comprehensive approach fosters financial prudence and supports sustainable institutional development by maintaining a balance between recurring expenses and capital investments.

BEST PRACTICE: 1

Title: Preparatory Pathway

OBJECTIVES:

1. To bridge the gap between school and collegiate education.
2. To prepare students for a classroom atmosphere where English is the medium of instruction.
3. To help students acquire basic learning, speaking, reading, and writing skills.
4. To enhance communication skills including active listening, presentation delivery, audience engagement, and real-world application.
5. To familiarize students with the vision and mission of the college.
6. To instill holistic values and cultural practices influenced by Jesuit traditions.

THE CONTEXT:

St. Xavier's College Burdwan has offered the "Preparatory Pathway" course since its inception in 2014, before the start of undergraduate programmes. This program acts as a buffer for new students, providing them with necessary preparation and orientation for college life. It aims to ease their transition and build confidence before they embark on their degree courses.

THE PRACTICE:

The Preparatory Pathway is conducted annually, typically spanning seven to ten days before the commencement of regular classes. The curriculum covers a variety of topics essential for new students to

adapt to college campus life, understand academic expectations, and familiarize themselves with support services available.

SYLLABUS FOR PREPARATORY PATHWAY:

- **Introduction:** Orientation to college vision, mission, and Jesuit values. Campus tour highlighting key locations.
- **Academic Orientation:** Overview of academic programmes, library services, university syllabus structure, grading system, and attendance procedures.
- **Campus Ethos:** Conduct guidelines and communication etiquette emphasizing respectful interactions.
- **Transition to College Life:** Balancing academics, social life, self-care, and mental health awareness.
- **Social Outreach:** Introduction to Jesuit education's objectives, promoting social justice and concern.

Specialized Workshop on LSRW Skills

- **Listening:** Audio clippings with Q&A sessions, reading passages and answering questions.
- **Speaking:** Self-introduction, group discussions, debates, storytelling, declamation, and summarizing texts.
- **Reading:** Newspaper and poetry reading, dialogue reading from plays, reading comprehension.
- **Writing:** Paragraph writing, formal letters, emails, leave applications, resume and summary writing. Students are grouped based on proficiency levels (advanced, average, slow) and receive tailored support from English and other department professors. Interactive sessions aim to boost confidence and prepare students for college life intellectually and socially.

The importance of punctuality, if taught to students at a young age, will help them in the long run. From self-confidence to better preparedness on the academic front, here are a few reasons why punctuality is important for the students in St. Xavier's College, Burdwan –

OBJECTIVES:

- To build a more self-confident and successful students.
- To build discipline from a young age and strengthen their character.
- To make attend maximum of all scheduled classes of their study.

THE PRACTICE:

At St. Xavier's College, Burdwan our teaching staff and faculties make sure they instill the right values in students from their youth. The college timing is from 10.30 a.m. to 4.10 p.m.

Students are expected to follow certain criteria like,

- Reporting to be on the campus by 10.15 a.m. to get ready for the first class.
- Not to come late or taken early leave from the college.
- Providing medical evidence for absences of more than three consecutive days is mandatory.
- Taking prior permission before going on a prolonged leave for any reason if it is known beforehand.
- Leave application must be submitted within three days of the student's absence.
- Carrying college identity card each day is necessary to enter into college premise.

Late Slip- This is introduced by the College for the students who comes late within the time range of 10.31a.m. -10.40a.m. The signature needs to be taken from the concerned members of the Discipline Committee of the College. To get the attendance of the first class the late comers need to submit it to the respective faculties.

Leave Slip- This yellow slip is required to be produced by the students who take only one day leave once they come to college with the signature of the signatory authority for one day and Fr. Vice principal/ Fr. Principal for two days. Failing to produce the leave slips the students will not get the attendance on that very day.

Excuse Record- This slip has two parts, one for the college and the other for the students to be kept. It is maintained for more than two days leaves along with one written application to the Vice- principal/ Principal. The student has to retain the counter part of the perforated slips. In case of illness a Medical Certificate should also be required.

Admit Slip- This slip is required if the late students want to attend the classes after 10.40 am once signed it from their respective HoDs though they will not get the attendance of the first class.

Early leave Slip -When early leave is required for any other purpose, prior permission from the Vice-Principal/Principal must necessarily be obtained for which the Early Leave Slip is required for the students. The students will be allowed to leave the campus early only if they produce this slip in the gate. Also, their guardians are informed from the college office about their early departure.

Attendance for Internship - if the internship is approved by the College, certificate of the competent authority of the respective organization is needed. All the scholarship/fee concession holders should earn (90%) of attendance, failing which the entire scholarship/fee concession amount has to be refunded to the college.

All these parameters are strictly maintained on daily basis by all the faculties under the supervision of the Principal, The Discipline Committee and The Attendance Committee.

At the end of each month, student attendance percentages are calculated by the Attendance Committee. In case of any discrepancy, they can write an application to the Principal. The college has an Attendance

Committee which on daily basis keeps a track of students' attendance through classroom registers and the late and leave slips.

OUTCOME:

Punctuality is crucial for students, offering stability, security, and self-confidence, leading to academic and professional success.
